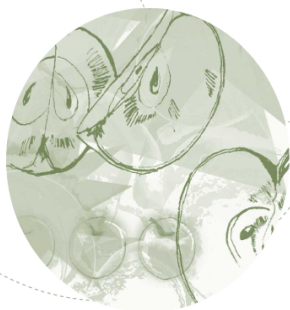

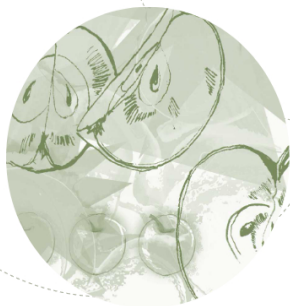

Dear cathy scratch,

On behalf of the United States Department of Agriculture's (USDA's) BioPreferred® program, I am pleased to inform you that your application for use of the USDA Certified Biobased Product Label for Terreplenish® has been approved as of November 19, 2014. The test result for Terreplenish® indicates that its biobased content is 97%. According to your application, you may now use the Label on the product Terreplenish®.

USDA will inform you that your certification is no longer valid. In this case, you must increase the biobased content of your product to be at or above the revised minimum and re-apply for certification within 60 days in order to continue to use the certification mark.
